Jordan in a cerrain tract of land in Maneys Neck Township, County aforesaid, known as Old Town, bounded on the North by the lands of Camp Manufacturing Company, on the East by the public road leading from Parker's Ferry to Como, on the south by the Meherrin River, on the West by Liverman's Creek, containing 578 acres, more or less. The swamp land adjoining and being a part of this farm, yet not included in the acreage aforesaid mentioned, is hereby included, acreage of swamp land unknown.
